



**MEMORANDUM OF UNDERSTANDING**

MALAYSIA**

**ON FRIENDSHIP, NETWORKING AND COOPERATION, PROMOTION  
OF MUTUAL UNDERSTANDING ON ACADEMIC, CO-ACADEMIC,  
CO-CURRICULUM AND SPORTS MATTERS AND PROFESSIONAL  
EXCHANGES ON EDUCATION IN GENERAL**

This **Memorandum of Understanding** is executed

**BETWEEN**

**PRINCESS CHULABHORN SCIENCE HIGH SCHOOL SATUN** (hereinafter referred to as "CHULABHORN", an education institution whose address is at Princess Chulabhorn Science High School Satun, 138 Moo. 12 Chalung, Mueang, Satun 91140, Thailand and shall include its lawful representatives and permitted assigns;

**AND**

**SULTAN BADLISHAH HIGH SCHOOL** (hereinafter referred to as "BADLISHAH"), a government-aided secondary school whose address is at Jalan Sultan Badlishah, 09000, Kulim, Kedah, Malaysia and shall include its lawful representatives and permitted assigns;

(hereinafter referred to singularly as "the Party" and collectively as "the Parties")

**WHEREAS**

- A. CHULABHORN is an established education institution with a track record of educational excellence and with a dynamic programme of collaborative arrangements with many international counterparts.
- B. BADLISHAH is a prestigious secondary school which strives to strengthen its international networking, and has entered into various collaborative arrangements with others to enhance its academic and co-academic links and cooperation.
- C. The Parties are keen of signing this Memorandum of Understanding to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

**NOW THIS MOU WITNESSES AS FOLLOWS:**

**ARTICLE 1: OBJECTIVE**

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations and national policies from time to time in force in each party's country, shall endeavour to strengthen, promote and develop academic, cultural, co-curricular and sports co-operation between the Parties on the basis of equality and mutual benefit.

**ARTICLE 2: AREAS OF COOPERATION**

- 2.1 Both parties agree to encourage the following activities, in particular, to promote international academic cooperation in the following areas:
- a. knowledge exchanges between members of both parties;
  - b. cooperation in services and consultancy related to interests in the field of education;
  - c. collaborations in carrying out competitions, programmes, seminars, conferences, publications and innovations in the field of education;
  - d. dissemination of information and activities under the Memorandum of Understanding on the websites and social media of the parties; and
  - e. cooperation in co-curriculum and sports and any other areas as agreed by the parties from time to time.
- 2.2 For the purpose of implementing the co-operation in respect of any areas stated in paragraph 2.1 the Parties shall have a mutual agreement to support each other and give commitment to ensure the success of the co-operation.

### **ARTICLE 3: FINANCIAL ARRANGEMENTS**

- 3.1 This Memorandum of Understanding shall not give rise to any financial obligation by one Party to the other.
- 3.2 Each Party shall bear its own cost and expenses in the implementation of this Memorandum of Understanding.
- 3.3 Each party shall bear its own cost and expenses in taking part in the activities, competitions, conferences or programmes held.

### **ARTICLE 4: EFFECT OF MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create, any legally binding or enforceable obligations, express or implied, under domestic or international law.

### **ARTICLE 5: ENTRY INTO EFFECT AND DURATION**

- 5.1 This Memorandum of Understanding shall become effective as of the date of signatures of both parties, or if the dates vary, then the date of the later signature.
- 5.2 This Memorandum of Understanding shall remain in effect for a period of FIVE (5) years.
- 5.3 This Memorandum of Understanding may be extended for such further period as may be agreed upon in writing by both parties.

### **ARTICLE 6: TERMINATION**

This Memorandum of Understanding may be terminated by either party with a minimum of THIRTY (30) days written notice. Activities in progress at the time of termination of this Memorandum of Understanding shall be permitted to conclude as planned unless otherwise agreed.

## **ARTICLE 7: NOTICES**

Any communication under this Memorandum of Understanding shall be in writing in the English language and delivered by registered mail to the address or sent to the electronic mail address or facsimile number of **Sultan Badlishah High School** or **Princess Chulabhorn Science High School Satun**, as the case may be, shown below or to such other address or electronic mail address or facsimile number as either Party may have notified the other Party and shall, unless otherwise provided herein, be deemed to be duly given or made when delivered to the recipient at such address or electronic mail address or facsimile number which is duly acknowledged:
