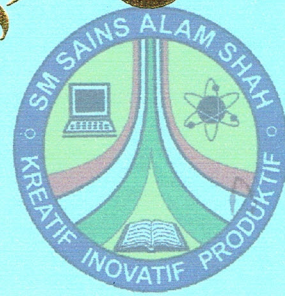

## MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING ( the "Memorandum") made this 27<sup>th</sup> day of April, 2015, by and between SM SAINS ALAM SHAH, KUALA LUMPUR ("Partner1") and PRINCESS CHULABHORN'S COLLEGE, SATUN ("Partner 2") regarding educational based programme.

### AGREEMENT:

4. Jointly identify and support reporting requirements of each organization.

## MEETINGS AND REPORTING

To accomplish these objectives, partners will meet at least 1 time a year for the purposes of programme planning and monitoring and evaluating outcomes. Decisions at the meeting will be decided by committee meeting.

## FUNDING and Financial Responsibilities:

Partner 1 and Partner 2 are responsible for the reasonable cost of the programme. Both partner will propose the costing if applicable.

## DURATION:

This MOU is at-will and may be modified with the mutual consent of the authorized individuals of Partner 1 and Partner 2. Once signed by authorized officials of both groups, this MOU will begin [April 27<sup>th</sup>, 2015] and remain in effect until [April 27<sup>th</sup>, 2017].




